#### MEET CONDITIONS AND INFORMATION

#### **VENUE**

- Leys Pool and Leisure Centre, Pegasus Road, Blackbird Leys, Oxford, OX4 6JL
- This is an 8 lane 25m pool with electronic timing (Colorado) and large pool deck
- Spectators welcome (entry fee is £6 per session or £10 for the day)

#### **AGE GROUPS**

 Age groups will be 9 & 10, 11, 12, 13, 14, 15, 16+ Age on the last date, except 400m events when minimum age is 10y & 100IM where the minimum age is 13y.

#### **ELIGIBILITY**

- Swimmers must be members of SE/WASA/SASA-affiliated clubs.
- Eligible to compete and registered in accordance with said laws and technical rules.
- Female category aligns with Swim England's Transgender and Non-Binary Policy.

#### **AWARDS**

- Heat Declared Winner (HDW) format.
- Medals awarded for 1st, 2nd, and 3rd place in each age group and event.

#### **ENTRIES**

- Entries should be submitted in Hytek Team Manager format.
- Entry times requested (coaches can provide club times if unavailable).
- Entry fee: £8 plus £1 admin fee, (£9.00 total) for all events. £25.00 per coach/team manager for all sessions, £15 for single day all sessions.
- Manual entries incur an additional £5.00 administration fee
- Payments via BACS to City of Oxford Swimming Club (Sort Code: 60-83-71, Account No.: 05372786). Use the reference: [Club Name] NOV25.
- Please submit the Club Summary by filling in <u>Google Form Club Summary</u>.

#### **CLOSING DATE**

- Entries open on the 20<sup>th</sup> October and close on the 31<sup>st</sup> October 2025.
- Free withdrawals accepted until 31<sup>st</sup> October 2025 when entries will close. We may need to close earlier if the meet becomes full.
- The promoter reserves the right if oversubscribed to extend the period of free withdrawals.
- Entries after this date will be at the promoter's discretion.

#### **ACCEPTED ENTRIES**

- Accepted entries will be sent to the club representative prior to the meet.
- It is the responsibility of the club representative to check entries for any errors in names, ages, or times and notify the promoter of any corrections.
- Failure to report errors may result in swimmers being excluded from events, and entry fees will not be refunded.
- Entries will only be processed once payment is confirmed.

#### REJECTIONS

#### This is a 'first come first served' meet, with priority given to clubs in the ONB county.

Entry acceptance priority will be as follows: -

- Clubs affiliated to the Oxfordshire & North Buckinghamshire (ONB) County.
- Should the meet become full before all ONB entries are accepted then those entries will be accepted on a 1st come 1st served basis.
- If spaces are still available, the remaining entries from non ONB clubs will then be processed also on a 1st come 1st served basis until the meet is full.
- The promoter reserves the right to close entries early once the meet is deemed full therefore acceptance of all entries is not guaranteed.
- The date and time the entry file is received by the meet organiser will be used as a base criteria for
  acceptance of entries. Entries will be accepted based on the date and time the entry file is received by the
  meet organiser.
- Clubs will be notified of any rejections as soon as possible.

#### **WITHDRAWALS**

- This is a cardless competition and an active withdrawal system will be in operation.
- Withdrawals are to be submitted for swimmers who are not intending to swim NO LATER THAN 15 MINUTES BEFORE THE START OF WARM-UP for that session.
- Withdrawal link will be provided in advance of the competition.
- The inclusion of an incorrectly withdrawn entry will be at the sole discretion of the promoter, subject to spare lanes being available in the first 2 heats and will be allocated on a first come first served basis.
- No refunds will be made for withdrawals other than on medical or compassionate grounds, (medical note must be provided).

#### **RESULTS**

- Results will be provided to Aquatics GB for inclusion in the national rankings database.
- Please note that electronic timing results displayed during the event are provisional and may be overruled by the Referee.

#### **POOLSIDE PASSES**

- One pass is required for each Coach/ Team Manager on poolside.
- Poolside passes are available to coaches or designated club officials supporting competing swimmers.
- Sufficient Adult Poolside Accreditation (DBS checked) must be available to maintain adequate supervision
  of their athletes. This is the responsibility of attending clubs.
- Attending clubs are responsible for ensuring poolside passes are issued only to Swim England members with a valid, in-date DBS.
- Please see Swim England Team Manager and Chaperone Policy SE1048 for full details regarding Poolside Adult to Swimmer ratios.

#### **PHOTOGRAPHY**

- Allowed under Swim England guidelines.
- Permission needed from the Head Referee for poolside filming.
- Mobile devices are strictly prohibited in changing rooms. Both sets of guidance apply if social media platforms are being used to share images or recordings either after the meet or during live streaming of the event.

#### **CONDUCT**

#### • Supervision and Responsibility:

- 1. All swimmers must always be under the direct supervision of their Club Coaches or designated poolside. Club Officials who hold valid poolside passes.
- 2. This supervision is particularly crucial during non-competition periods or between sessions.
- 3. Coaches are responsible for ensuring swimmers meet the competency standards of the Swim England Competitive Start Award.

#### Warm-Up Periods:

Swimmers are the sole responsibility of their Club Coaches or poolside Club Officials during warm-up sessions, as no warm-up marshals will be provided.

#### Safety Precautions:

- 1. All participants must adhere to safety measures in operation at Leys Pool and Leisure Centre.
- 2. Over-the-top starts will be used wherever possible to streamline event timing.

#### • Prohibited Behaviour:

- Inappropriate behaviour, including misuse of equipment, disruptive conduct, or failure to follow instructions from meet officials, may result in the individual being asked to leave the competition and/or venue without a refund.
- 2. Mobile devices are strictly prohibited in changing rooms. Any swimmer or spectator found using mobile devices in prohibited areas will be required to leave the competition immediately without refund.

#### Out-of-Bounds Areas:

The Learner Pool is strictly out of bounds for all swimmers during the meet.

#### Responsibility and Liability:

Neither the Promoter nor City of Oxford Swimming Club will accept responsibility for any loss, damage, or injury occurring during the meet.

Failure to comply with the above may result in the Competitor's entry being withdrawn without refund.

#### **DATA PROTECTION**

 By submitting entries, consent for data processing in accordance with the Data Protection Act 2018 is implied.

#### **GENERAL**

- There is no catering facilities open on site, so please bring appropriate food and beverages for those attending the meet.
- Please note, as this venue is a Leisure Centre the changing facilities are open to the general public during the Meet.
- Large swimming bags will not be allowed on poolside, please bring a small poolside bag. Lockers are available to leave belongings securely. Please bring a padlock.
- Swimmers must wear suitable clothing and footwear on poolside and when moving around Leys Leisure centre and pool.

#### **CAR PARKING**

- There are limited spaces available at leys pools and leisure centre. Car parking restrictions have been lifted so there is no need to renew your ticket every three hours.
- There is plenty of parking situated on local roads in the area.

#### **OFFICIALS**

- Clubs are expected to provide Officials to support the meet. This is to enable the smooth running of the meet.
- Anyone who can help officiate, please confirm availability on the <u>Swim Meet</u>.
- In the event of an insufficient number of Officials being available for any session, the promoter reserves the right to curtail or otherwise cancel that session.
- Meals and refreshments will be provided for those officials doing more than one consecutive session.

#### **PROMOTER**

The Promoter reserves the right to:

- Address matters arising on the day where prior approval is not possible to ensure the smooth running of the meet.
- Nominate a Meet Manager to act as the Promoter's representative during the event.
- Make changes to session timings if there are insufficient entries or due to other unforeseen circumstances.
- Limit entries or reject swimmers based on the Meet Conditions to meet gala timing restrictions.
- Withdraw any Competitor's entry into this Meet without refund if they fail to comply with the rules and conditions outlined in this document.
